

PAFP Foundation Research Day Presenter Agreement

THIS RESEARCH DAY PRESENTER AGREEMENT (this “agreement”) is made as of February 27, 2026 by and between the Pennsylvania Academy of Family Physicians (the “PAFP”) and (PRESENTER NAME) (the “Presenter”).

WHEREAS, the PAFP wishes to retain the Presenter, and the Presenter wishes to be retained, to provide the services and materials set forth herein.

NOW THEREFORE, the parties agree as follows:

1. **AGREEMENT.** The PAFP agrees to retain the Presenter, and the Presenter agrees to be retained by the PAFP for the purpose of presenting on the topic set forth below in Section 2(c) at the PAFP Research Day conference (the “Conference”), a featured track within the Connect Conference, which will take place on Saturday, April 4, 2026, at the Wind Creek Conference Center, Bethlehem, Pennsylvania, from 10:00am – 5:30pm.
2. **DUTIES AND RESPONSIBILITIES.**
 - a. The Presenter agrees to deliver the presentation described below, to provide appropriate accompanying materials (if applicable) to PAFP, and to complete all other actions in accordance with the terms and conditions set for the in the Agreement and in accordance with the schedule that the PAFP shall reasonably request from time to time, including, but not limited to the following:

- b. For *Oral Presentations*, the PAFP will provide the Presenter a laptop with AV package (screen, podium, microphone, wi-fi) and final version of the PowerPoint presentation pre-loaded.

- c. The Presenter's anticipated presentation schedule is as follows:

3. **TERM AND TERMINATION.** The term of this Agreement will end on the date of the Research Day event listed in Section 2(c). Either party may terminate this Agreement for any reason as long as such party provides written notice to the other party at least fourteen (14) days prior to the Research Day event. Upon early termination of this Agreement, neither party will be liable to the other for any damage or loss sustained by reason of, or resulting from, the termination of this Agreement.
4. **INDEPENDENT CONTRACTOR.** The parties agree that the Presenter's status under this Agreement is that of an independent contractor and that the Presenter is not an employee of the PAFP. As an independent contractor, the Presenter is not eligible to participate in the PAFP's benefit plan.
5. **THE PRESENTER'S OWNERSHIP AND USE.** As between the PAFP and the Presenter, the Presenter will be the sole owner of any materials developed, submitted and/or used by the Presenter in connection with the event. The Presenter represents and warrants (a) that the Materials are factually accurate and contain no libelous or otherwise unlawful statements; (b) that the Presenter is the sole author and owner of the Materials and/or has obtained the right to use and license the Materials as contemplated hereunder; and (c) that such use and license will not violate the proprietary or personal rights of any third party (including, without limitation, copyrights, trademarks or privacy rights).
6. **PRESENTER'S GRANT OF RIGHTS TO THE PAFP.** The Presenter grants to the PAFP and its designees the following rights and licenses on a non-exclusive, irrevocable, worldwide, sub-licensable basis:
- The right to use the Presenter's name, likeness, image, photograph and biographical data in connection with the promotion and distribution of the presentation and/or materials and any PAFP activities related thereto;
 - The right to include all or part of the materials in presentation slides, handouts and other event materials, which are made available in any form or format, including, without limitation, print, current and future electronic media and the Internet (collectively, "Format"), and the right to revise any such Materials as reasonably determined by the PAFP for such inclusion;
 - The right to record the Presenter's presentation and/or Materials on audio/video and to reproduce, distribute, live stream, sell and otherwise make available transcripts, copies, on-demand products and/or recordings of the same, in whole or in part, for any lawful purpose and in any Format;

- d. The right to make derivatives of all or part of the presentation and/or materials and to include the same in reprints, anthologies, translations and any other PAFP products or publications; and
- e. The right to share Presenter's name and email address with third parties who have questions about Presenter's materials.

The Presenter represents and warrants that the PAFP's exercise of any such rights will not violate the rights of any third party. This Section 7 will survive any termination of this agreement.

7. **FORCE MAJEURE.** Neither party will be responsible for any failure to perform under this Agreement or in the event the PAFP is unable to proceed with the event due to causes beyond its reasonable control, including, but not limited to, acts of God, war or terrorist activity, government regulation, epidemics or pandemics, power outages, labor disputes or serious accidents.

8. **MISCELLANEOUS.**

- a. **Modification; Waiver.** This Agreement may be modified or amended only by a written instrument executed by both parties after the date hereof. The PAFP's waiver of any provision or default under this Agreement will not constitute a waiver concerning any other provision and will not affect the PAFP's right to thereafter exercise any right or remedy concerning any other provision or default whether similar or not.
- b. **Entire Agreement.** This agreement and any documents and instruments executed in connection with this Agreement constitute the entire agreement between the parties with respect to the subject matter herof and supersede all other prior agreements and understandings, both written and oral, between the parties with respect to the subject matter hereof.
- c. **Notices.** All notices, consents, approvals and other communications herunder ("Notices") shall be in writing only and shall be sent by electronic mail (email) or USPS addressed to the parties at the addresses set forth below or such addresses as either party may hereafter designate as its notice address:

All notices shall be deemed given on the date postmarked or transmitted by email; therefore, it being agreed tat refusal or inability to deliver because of a change of address for which no Notice was given shall constitute delivery as of the date such delivery was attempted.

- d. **Assignment.** This Agreement will be binding upon and inure to the benefit of the parties hereto and their respective heirs, legal representatives, sucessors and permitted assigns. Neither party shall assign all or any part of this Agreement without the prior written consent of the other party.

- e. Governing Law. This Agreement will be construed and interpreted in accordance with and governed by the laws of the State of Pennsylvania without regard to its conflicts of law principles.
- f. Counterparts. This Agreement may be executed in one or more counterparts, including by email, facsimile or other electronic means, each of which will be deemed to be an original copy of this Agreement and all of which, when taken together, will be deemed to constitute one instrument.
